Each attorney licensed in North Carolina who reports providing 50 hours of pro bono legal services in a year will be inducted into the North Carolina Pro Bono Honor Society and receive a certificate from the Supreme Court of North Carolina honoring their achievement.

# What is pro bono?

North Carolina Rule of Professional Conduct 6.1 states that "every lawyer has a professional responsibility to provide legal services to those unable to pay."

# Pro bono legal services are provided without fee or expectation of fee to:

- persons of limited means;
- charitable, religious, civic, community, governmental and educational organizations in matters that are designed primarily to address the needs of persons of limited means; or
- individuals, groups or organizations seeking to secure or protect civil rights, civil liberties or public rights, or charitable, religious, civic, community, governmental and educational organizations in matters in furtherance of their organizational purposes, where the payment of standard legal fees would significantly deplete the organization's economic resources or would be otherwise inappropriate.

There is only **1 LEGAL AID ATTORNEY** for every 8,900 of those eligible to be served in NC

### Find opportunities on Pro Bono Go.

**Pro Bono Go** is an online platform that makes it easy for North Carolina lawyers to search and share pro bono opportunities. You can find opportunities that are litigation-based or transactional, provide training, and fit your schedule

From January through March, attorneys can report their pro bono hours for the previous year. Reporting

your time helps showcase attorney volunteerism in North Carolina, inspires your peers to get involved, enables the idenfication of areas to grow pro bono efforts, and it's an opportunity for recognition.
